- Submit application prior to September 12th. Incomplete applications will not be accepted.
- Submit proof of insurance, adding the Historical Society on as additional insured.
- Comply with all Ventura County Health and Safety standards.
- Submit a copy of your current Mobile Food Facility (MFF) or complete a Temporary Food Facility (TFF) application
 - VCEH Application: <https://rmadocs.venturacounty.gov/environmental-health/programs/consumer-food-protection/forms/environmental-health-temporary-food-facility-type-1-operator-application.pdf> (the completed TFF application must and attach it to their application.
- All Salsa competition applicants are asked to provide salsa tasting samples, chip samples, and the container to serve the sample.
- Make payment to Simi Valley Historical Society (\$50 per booth)
- There will be limited electrical available, and no water hookups. Applicant booth must be self-contained.
- Acceptance of Salsa competition applications will be contingent upon receipt of a valid Ventura County approved MFF or by attaching a completed VC Health TFF application, a copy of your Certificate of Insurance, listing Simi Valley Historical Society as an "additional insured" endorsement.
